Fees Schedule

The tables below set out the Company's standard fees subject to and incorporated into the Terms and its definitions. Any variation to the Fees and to the Terms are subject to written agreement by the Parties to be laid down in the Assignment Confirmation. Agreed variations take precedence over the Terms in the event of conflict.

Permanent Contingent and Retained Search Placement Fee

Annual Remuneration Package	30 %

Permanent Retained Assignment Fee

Retainer Fee:	1/3rd of Estimated Remuneration Package invoiced on Client signing of the Agreement or the Assignment Confirmation and accepting the applicability of these Terms.
Shortlist Fee:	1/3rd of Estimated Remuneration Package invoiced on presentation of a shortlist, which shortlist will be fleshed out in the Assignment Confirmation.
Completion Fee:	Balance outstanding of Fee, adjusted for any variance between the Estimated Remuneration Package and Annual Remuneration Package, invoiced upon a Candidate's acceptance of offer of an Engagement. If a Retained Assignment is cancelled after the presentation of a shortlist, then 80% of the Completion Fee (based on Estimated Remuneration Package) shall be invoiced and payable.

Retainer and Shortlist Fees are non-refundable.

Fixed Term Placement Fee (Pro Rata As Per Contract Duration)

Annual Remuneration Package	30 %

Where the Engagement is extended beyond the initial fixed term or where the Client re-engages the Candidate within 12 months from the date of planned or actual termination (as applicable) of the first Engagement, the Client shall pay a further fee based on the Remuneration applicable for the period of Engagement following the initial fixed term period up to the termination of the second Engagement or until the Candidate has been engaged for a total of one year.
